With the sound of period cannons and rifles, the garrison sized Confederate Battle Flag was dedicated and raised to the top of a 100-foot flagpole on Saturday, May 26.

The flag and two statues were placed on private land and funded by the Sons of Confederate Veterans and the Order of the Rose. The flag and memorial is located approximately 3 miles west of Double Springs on Highway 278.

In speeches preceding the raising of the flag, it was pointed out that many of the Confederate monuments have been removed and this flag and monuments are in effect, a response to that movement to remove Civil War monuments found offensive to some.

[NASHVILLE, Tenn.](#) - Tennessee Governor Bill Haslam has signed into a law the Heritage Protection Act, which was proposed in response to the removal of Confederate monuments in Memphis.

The act requires a waiver from the Tennessee Historical Commission before public property containing a statue is sold or transferred, or a statue, monument, or historical marker is removed.

The act came in response to Memphis officials selling two public parks in December to the non-profit Memphis Greenspace, which then removed the statues of Confederate General Nathan Bedford Forrest and Confederate President Jefferson Davis.

A Davidson County judge ruled last week that the sale of the parks and removal of statues in Memphis did not violate the law.

The new legislation requires a waiver in future cases, and also bans any public entity that violates the law from receiving grants from the Historical Commission and the state Department of Economic and Community Development for five years.

The law also allows for anyone with “a real interest in a memorial” to seek an injunction if they believe the law has been violated. The court could then issue a restraining order or injunction.
